INTRODUCTION

The Civilian Conservation Corps (CCC) in Tennessee Collection (1933-1942) is the result of a cooperative effort by the Tennessee Department of Conservation, Division of Parks and Recreation and the Tennessee State Library and Archives. The records were obtained by James B. Jones, Jr., Director of the Department of Conservation's project entitled "The Civilian Conservation Corps – Its Legacy to Tennessee."

The materials in this finding aid measures 1.26 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in Civilian Conservation Corps (CCC) in Tennessee Collection the may be made for purposes of scholarly research.

SCOPE AND CONTENT

The Civilian Conservation Corps (CCC) in Tennessee Collection, containing approximately 150 items, covers the period 1933-1942. The collection is composed of correspondence, interviews, memorabilia, military records, photographs, a song, reports, and a special category.

There is a small amount of correspondence from Tennesseans who served in the Civilian Conservation Corps. These letters generally concern various items donated to this collection. In addition, some data relative to individual experiences in the C.C.C. may be found. Correspondents are James O. Rickman, Mrs. John L. Seawell and John A. Woolley.

There are nineteen cassette tape recordings of interviews with several former C.C.C. workers individually and at various reunions in the latter part of 1983. These interviews supply recollections of C.C.C. experiences. The list of interviewees and the dates of the interviews are found in Box 1, Folder 2. Memorabilia consists of C.C.C. sleeve patches.

Military records include certificates of discharge, company histories, menus and rosters and a "201 file" of Glenn DePriest, C.C.C. Co. 1455, consisting of appointments, bulletins, camp newspapers, certificates, correspondence, leaves of absence, memoranda, orders, resolutions and rosters.

Most of the photographs are of single individuals, small groups or companies. Others show camp barracks, conservation work and recreational activities. One unusual picture shows a tree with both ends rooted (see Box 3, Folder 15). The tree picture was submitted and appeared in a Ripley "Believe It or Not" cartoon.

"High 'Cs" is a song of the Civilian Conservation Corps composed by North Callahan. A tape of the song is found with the rest of the cassette recordings in the collection.

There are two field reports on the conservation work of the C.C.C. in Tennessee: Fall Creek Falls Recreational Demonstration Area and Montgomery Bell Project Reclamation Area.

The special category features the 50th Anniversary Reunion of C.C.C. Co. 1455 in 1983.

The Civilian Conservation Corps (CCC) in Tennessee Collection along with Record Group 93, Civilian Conservation Corps, provides valuable research data for this aspect of twentieth century Tennessee history.
