INTRODUCTION

The Foster Family Papers (1799-1918) are centered around Joseph Foster (1792-1865), farmer and public official of Maury County, Tennessee. The Foster Family Papers are a gift of Miss Mary Alice Foster, Nashville, Tennessee through the agency of Mrs. Charles Alexander, Columbia, Tennessee.

The materials in this finding aid measure 1.26 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the Foster Family Papers may be made for purposes of scholarly research.

SCOPE AND CONTENT

The Foster Family Papers, containing approximately 500 items, span the period, 1799-1918. The collection, concentrating primarily on Maury County, Tennessee, is composed of accounts, correspondence, court records, genealogical data, land records, legal documents, military records, printed materials, slave records, taxes, and several miscellaneous items.

The accounts largely reflect transactions of the Foster Family in Maury County and Nashville, Tennessee. Accounts concerning cotton, merchants, school tuition, doctors, blacksmiths, undertakers, and seamstresses are included. Some of the merchants include J. L. Williams & Co.; W. A. Nichols & Co.; Salisby, Frierson, Dale & Co.; Ben. N. Noel & Bro.; Johnson & Weaver.

The court records contain the judgements and summons of the justices of the peace; along with other Maury County court records. Also included are the Superior Court records of Clark County, Georgia. A Federal certificate of bankruptcy for John D. Stockard is included with the court records.

The land records contain several deeds for land purchased by the Foster family. Two of the deeds concern land in Abbeville, South Carolina. Several property surveys are also included; one for the property in South Carolina.

A major portion of the Foster Family Papers includes the legal documents, most of which reflect Joseph Foster's responsibilities as administrator or guardian. Also included are wills, a deed of trust, and licenses.

The military records concentrate on the War Between the States, and contain an honorable discharge, oaths of allegiance, passes and receipts. Also included are commissions in the South Carolina and Tennessee militias.

The slave records include several bills of sale and information on slave value and slave auctions. An unusual document in the collection is the agreement between Joseph Foster and the "black people" on his farm.

The Foster Family Papers include some unusual documents such as a large chronological chart of world events, Tennessee and Kentucky script, a weaving pattern, advertisements, and printed materials.
