INTRODUCTION

The Bolling Gordon Family Papers, 1794-1960, are centered around Bolling Gordon (1800-1890), member of Tennessee State House of Representatives and Tennessee State Senate, of Hickman County, Tennessee and his descendants of Maury County, Tennessee. This collection occupies 5.04 linear feet of shelf space and photocopies of unpublished writings in the Bolling Gordon Family Papers may be made for purposes of scholarly research.

SCOPE AND CONTENT

The Bolling Gordon Papers, consisting of approximately 1000 items, span the period of 1797-1960. The collection consists of accounts, cards, cemetery records, certificates, correspondence, eulogies, financial documents, genealogical data, invitations, land records, legal documents, memorials, photographs, poetry, printed materials, reports, scrapbooks, sketches and writings.

The correspondence is mostly from the wife and daughter of Richard Cross Gordon (1837-1903), son of Bolling Gordon (1800-1890), and his family in nature. Other correspondence of importance are two letters from James Knox Polk (1795-1849) and two letters from Cave Johnson (1793-1888), Postmaster General under President James K. Polk.

Genealogical data can be found on John Gordon (1763-1819) and his descendants of Maury County, Tennessee. Also included is genealogical data on Jonathan Webster family, great-grandfather of Mary Camp (Webster) Gordon, wife of Richard Cross Gordon.

In the collection are memorials for Camille Gordon and Captain John Gordon and a sketch of a memorial window for a country church.

The writings include "Captain John Gordon of the Spies" by Camille Gordon and "My Grandmothers Flower Garden" whose author is unknown.

Also included in the collection are several Daughters of American Revolution membership certificates.

There are sketches so two cemetery markers: the Frierson family and of Captain John Gordon (1763-1819).

Photographs are of family members.

Overall the collection provides substantial information on a prominent Hickman County and Maury County, Tennessee family of the nineteenth century.

BIOGRAPHICAL SKETCH

Bolling Gordon was born on April 12, 1800 in Nashville, Tennessee to John and Dorothy (Crois) Gordon. He served as a surveyor in Illinois before 1830. From 1829-1835 he served in the House of Representatives of the Tennessee legislature representing Hickman and Dickson counties in the 18th, 19th and 20th General Assemblies. He married Mary Elizabeth Watkins of Farmville, Virginia, daughter of Captain Joel and Mary (Jones) Watkins in 1830. In 1835, he represented Hickman County, Tennessee in the State Constitutional Convention. From 1835-1837, Gordon served in the Tennessee Senate representing Hickman, Wayne, and Lawrence counties in the 21st and 25th General Assemblies. From 1836-1840, he served as presidential elector on the Democratic ticket supporting Martin Van Buren. In 1847, he was an unsuccessful candidate for Congress. In 1850, he served as a delegate to the Nashville Convention. In 1861, Gordon was elected to proposed State Convention to consider withdrawal from the Union but did not serve because of proposal to hold convention was defeated at the polls. In 1870, Gordon again represented Hickman County, Tennessee in the State Constitutional Convention. In November of 1890, Gordon died at "Cottage Hill" and was buried at Rose Hill Cemetery in Columbia, Tennessee.
