INTRODUCTION

This finding aid focuses on the James-Payne Ancestors Genealogical Materials, 1778-1990, by Margaret Travis Gray (1923-) of Louisville, Kentucky, in 1989. The collection consists of copies of records compiled by Mrs. Gray on the James and Payne and related families of Althan, Banks, Barne, Blank, Brook, Canterbury, Catlett, Davis, Dormer, Doughty, Frith, Gaines, Grymer, Hassel, Hawtrey, Hildersham, Kilpatrick, Kincheloe, Langston, Malton, Martin, Mathew, Sloan, Stanfield, Stribling, Taliafero, Tunstall, Turner, and Wollaston of Neshoba and Newton Counties in Mississippi; Pendleton and Anderson Counties in South Carolina; Middlesex County in Virginia; and Elbert County, Georgia.

The materials in this finding aid measures 1.5 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the James-Payne Ancestors Genealogical Materials may be made for individual or scholarly research.

SCOPE AND CONTENT NOTE

The James-Payne Ancestors Genealogical Materials compiled by Margaret Travis Gray, containing approximately 1200 items span the period 1778-1990, although the bulk is confined to 1820-1900. the collection is composed of cemetery records, census records, clippings, correspondence, D. A. R. records, family reunion records, genealogical data (family group sheets, generation/ancestor charts), heraldry, land records, legal documents, (wills, deeds), maps, military records (Revolutionary and Civil War), and photographs.

The genealogical data relate to the ancestors of the mother of Mrs. Gray's husband, Dr. William R. Gray, Sr., in Mississippi.

The collection was received from the donor in notebook binders, each with a table of contents an index. This arrangement has been maintained in the processing of the collection.
