SCOPE AND CONTENT NOTE

The Stanley Fitzgerald Horn Papers, containing approximately 9600 items, cover the period 1938-1980, although the bulk of the papers are limited to the years 1946-1980. The collection is composed of accounts, announcements, associations - institutions, etc., book reviews, cards, certificates, clippings, correspondence, financial documents, genealogical data, insurance papers, photographs, sketches, special subjects, speeches, taxes, writings and several miscellaneous items.

Stanley F. Horn (1889-1980) was an active member of many local, state, regional and national organizations whose aims are to preserve the past while promoting the goals of the present. These associations ranged in diversity from the Tennessee Historical Society and the Chicago Civil War Round Table to the Lumber Trade Gulf Association and the Watkins Institute Board of Commissioners. Much information for the Tennessee Civil War Centennial Commission, the Tennessee Historical Commission and the Tennessee Historical Society for the early years of the 1960s may be found in the Horn papers. Correspondence, minutes, printed materials and other related organizational items are arranged according to the respective associations.

As an editor for the Chicago Civil War Book Club, Horn often reviewed proposed book selections. These book reviews may be found within the correspondence of the Chicago Civil War Round Table. Other book reviews are within the general correspondence section with various publishing firms. In addition, there are a few miscellaneous book reviews.

General business correspondence, both incoming and outgoing, comprise one half of the Horn Papers. These letters cover such common topics as: Civil War battle-fields and military leaders, Confederate books and manuscripts, antique collecting, invitations to speak, requests for autographed copies of books, arrangements for the publishing of Horn's manuscripts, and permission to quote from Horn's books. Almost all of the incoming correspondence has Horn's replies attached.

Prominent correspondents include Sherman Adams, Lamar Alexander, Clifford Allen, Victor Ashe, W.E. Beard, Landon C. Bell, Campbell H. Brown, Gordon Browning, Roger Butterfield, Bruce Catton, Frank G. Clement, Albert Gore, Jr., B.H. Liddell Hart, Mrs. William Randolph Hearst, Jr., Stewart Holbrook, Harold M. Hyman, Estes Kefauver, Evelyn Lincoln, Arthur S. Link, Henry Cabot Lodge, Jr., Walter Lord, Douglas McKay, Mrs. John Trotwood Moore, Ralph Newman, J. Percy Priest, Sam B. Smith, Irwing Stone, William Waller, Sinclair Weeks, Ben West, W.D. Westmoreland, and Desmond Young.

Genealogical data for the Horn and related families of Ferebee, Goodrich, Graves and Irion may be found in the collection. There is also miscellaneous genealogical data for the Dozier, Juzan, Newsom, Robinson and Toumlin families.

Special subjects include the <u>Southern Lumberman</u>, a trade journal of the lumbering industry in the South. Mr. Horn was the editor and publisher of this publication from 1917 until his death in 1980. The collection contains correspondence, both domestic and foreign, and photographs of various lumber men and lumbering mills which were used in past issues of the <u>Southern Lumberman</u>.

Among the writings of Stanley F. Horn are the manuscripts for The Army of Tennessee, the Robert E. Lee Reader, This Fascinating Lumber Business and Tennesse's War.
