## **INTRODUCTION**

Wallace Alexander Jones (1907-) collected and compiled these materials. A native of Brazil and Trenton (Gibson County), Tennessee, he was for many years Law Librarian in the U.S. Department of Agriculture Library, Washington, D.C. Mr. Jones donated the collection to the Tennessee State Library and Archives in 1963.

The materials in this finding aid measure 4.87 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the Wallace Alexander Jones Genealogical Collection may be made for purposes of scholarly research.

## SCOPE AND CONTENT

This collection spans approximately the period 1860-1963, although much of the genealogical data refers to earlier periods. Numbering approximately 3,000 items, 3 volumes and one reel of microfilm (Mf. 157), the collection contains correspondence; memoirs; applications to patriotic organizations; certificates; clippings; coats of arms; genealogical data; pictures; school records; and exhibits supporting the data, including death certificates, estate records, inventories of property, land records, marriage bonds, and certificates, military records, and wills.

Materials in the collection pertain largely to Gibson, Maury, and Tipton counties, Tennessee, as well as DeWitt and Gonzales counties, Texas. Several letters were written from Memphis (Shelby County), Tennessee.

There is genealogical data for the Allen, Alston, Bynum, Carothers, Carthel, Comer, Courtney, Dockery, Edwards, Exum, Fitzgerald, Hinton, Holloway, Jones, Linington, McLemore, Morehead, Neville, Norman, Peake, Perkins, Perry, Reilly, Sanford (Sanford), Shaw, Smith, Stradling, Sugar(s), Tanner, Thompson, Turner, Wilkins, Williams, and other families.

Seventeen letters (typed copies) comprise the incoming correspondence (1860-1868) of Adeline "Addie" (Jones) Wilkins Crisp (1843- ) and span Addie's school days, her marriage (1863) to Lucius J. Wilkins (1832-1863), and her later marriage to Dr. James Jones Crisp (1832-1877), prominent physician of Fayette County, Tennessee. The letters written by Addie's father, Thomas Jones, a Memphis (Shelby County), Tennessee, businessman, and by other friends and relatives, reflect the growing feeling of disunion in 1860 and the coming of the war, health and financial conditions in Memphis, and family life and friends in Maury County, Tennessee; they also describe the deaths (1866) of Addie's father and grandfather due to cholera. Some of the letters were written from the old home place in Trenton (Gibson County), Tennessee.

There is a letter (1955) from Herbert Hoover; several (1931, 1948, 1955) from John Motley Morehead, III, internationally known scientist, author, and benefactor of the University of North Carolina and American minister to Sweden, and others concerning the request for issuance of a commemorative stamp bearing the likeness of Mrs. Kerenhappuch Norman Turner in honor of the 175<sup>th</sup> anniversary of the Revolutionary War Battle of Guilford Courthouse, North Carolina. Also included are a letter (1958) from T. Zerligowski, Director, Central Agricultural Library, Warsaw, Poland, regarding his visit to the U.S. Department of Agriculture Library, as well as two letters (1950) from a London friend reflecting English thought concerning world affairs and the war in Korea. Letters from Jere Cooper (1932), Kenneth McKellar (1933), and others recommend Jones's work in the U.S. Department of Agriculture Library. There are also several Worth S. Ray letters concerning the Jones family.

Items of interest include a copy of the commission from King George II for inquiry into the grievances in Isle of Wight County, Virginia and data (including speeches, prayers, etc.) at the time of the execution of John Jones (d. 1660), one of Charles I's judges.

The Hinton family scrapbook contains coats of arms and data for the Hinton, Alston, Lovell, Stopham, and Stradling families, with pictures and descriptions of historic English churches and castles in England, Scotland, and Wales.

Personal papers of the collector include a friendship book (1924-25) giving snapshots, clippings, and autographs of students at Humboldt High School (Gibson County), Tennessee.

Among the photographs are many pictures of family homes in Trenton and Brazil (Gibson County), Tennessee, and a few other locations. Included are photographs of many family members and tombstones.

The large (520 pp.) bound volume, *Remnants of Former Glory*, by Jones, is a condensed compilation of much of the genealogical data in the collection. Included is material on the Jones and many related families with much biographical material and many anecdotes given. An extensive personal name index adds to the value and usefulness of the volume. Jones at one time planned to revise this volume and publish three books: (1) Edward and Abigail (Sugar) Jones of Virginia and North Carolina; (2) Mrs. Kerenhappuch (Norman) Turner (Mrs. James Turner); and (3) Capt. Charles Allen of Virginia and North Carolina. Descendants of all these and other families settled in Tennessee in the early 1800s (approximately 1804-1828).

The arrangement of unbound data in the collection has been by family where possible, with documenting records placed within the family's data. Letters primarily giving genealogical data reside with the family discussed, while correspondence of a general nature appears by author. Census and land records and photographs are filed separately with notation of the families involved added.

Areas of concern to Jones, which are reflected in the collection, include the request for issuance of a stamp picturing Mrs. Kerenhappuch (Norman) Turner in commemoration of the 175<sup>th</sup> anniversary of the Battle of Guilford Courthouse; monuments at the Guilford Courthouse National Military Park, Greensboro, North Carolina; and Lady Godiva.

In his research, the collector concentrated on his own family lines, rather than doing genealogical research for others. Thus, a close family connection is readily apparent in much of the data. Especially this is true of the Jones-Alston, Jones-Carthel, Morehead-Carthel, Morehead-Turner, Sandford-Reilly, Sandford-Turner, and Turner-Norman connections.

Outstanding members of family lines traced include Lady Godiva and Lord Leofric; Mrs. Kerenhappuch (Norman) Turner (Mrs. James Turner); John Motley Morehead III, internationally known scientist and American minister to Sweden; John Motley Morehead I, Governor of North Carolina; and Joseph Alston, Governor of South Carolina.

Also included are photocopies of portions of the transcript memoir (1789-1860) of James Norman Smith (1787-1875). In the memoirs of "Uncle Jimmie Smith", who lived in Richmond County, North Carolina, Middle and West Tennessee, and south Texas, Smith records his experiences as a teacher in Maury County, noting that one pupil was James K. Polk. Also noted are his experiences in Texas just prior to the Mexican War, 1846-1848; his membership in the Presbyterian Church; and genealogical data on the Morehead, Murphee, Sandford, Turner, and related families. A later addition (Box 13) does not appear on microfilm and contains numerous photographs of the Jones family including Bobby L. Jones, Cecil Clifford Laird Jones, Cecil Laird Jones Jr., John Washington Jones, Edna Mae Keel Jones, Martha Ann Jones, Martha Thomas Hamilton Jones, Claudine Jones, Elizabeth Jones, and Lulu Jones.

## **BIOGRAPHICAL SKETCH**

### **Wallace Alexander Jones**

- 1907 Born June 6, in Brazil (Gibson County), Tennessee, the fifth son of Samuel David Fleming Jones (1864-1943) and Nancy Jane Linnington Allen Jones (1868-1967)
- ca. 1919 Moved at age twelve with his parents to Trenton (Tennessee) where he lived until he was fifteen
- 1925 Graduated from Public County High School, Humboldt (Gibson County), Tennessee, attended Union University, Jackson (Madison County), Tennessee
- 1929 Graduated from Washington University, St. Louis, Missouri, with a B.A. degree. During this time he studied voice under Mrs. Clark Eagle, who for many seasons was soloist for the St. Louis Municipal Opera. Jones sang in the choir of the Second Presbyterian Church
- 1931 Received Bachelor in Theology degree from The Southern Baptist Theological Seminary, Louisville, Kentucky
- 1932 Received Master in Theology and Graduate in Theology from The Southern Baptist Theological Seminary, Louisville, Kentucky
- 1933 Studied for Ph.D. degree at the seminary; began work with the United States Department of Agriculture
- 1934-35 Was Professor of Archaeology in the Baptist Bible School, Washington, D.C.
- 1941 Received Bachelor of Arts degree from The George Washington University, Washington, D.C.
- 1942 Enlisted in the U.S. Army November 3
- 1943 Entered active service February 17; as PFC in Co. D, 30<sup>th</sup> Sig. Tng. Bn.
- 1944 Completed program of studies prescribed by United States Armed Forces at the University of Nebraska, Lincoln, Nebraska; was discharged; no foreign service

- 1946-47      Was Post Commander, United States Department of Agriculture Post No. 36, American Legion, District of Columbia
- 1950          Visited Europe and Coventry, England, home of his famous ancestor, Lady Godiva
- 1969          Is living in Memphis, Tennessee

Jones was Law Librarian in the United States Department of Agriculture, Washington, D.C., for many years. He was occupied at times in various Baptist pulpits in Tennessee, Delaware, Kentucky, Maryland, Missouri, Virginia, West Virginia, and Washington, D.C. He was a Shriner; past commander of an American Legion post; and member of various patriotic societies, such as the North Carolina Society of the Cincinnati and the National, Virginia, and North Carolina Societies of the Sons of the American Revolution. He claims descent from Lady Godiva and Lord Leofric; William the Conqueror; Charlemagne of France; King Alfred of England; Hardreick, first Saxon King of England; and Oliver Cromwell.
