INTRODUCTION

This finding aid focuses on the papers of David (Dave) King, business and extensive landowner, of Manchester, Coffee County, Tennessee. Although spanning the years 1901-1978, the papers are largely concentrated around Mr. King in the period 1940-1970. The papers contain numerous land records in Coffee County as well as financial documents relating to the Dave King Auction Co., and the King Hardware and Furniture Co., in Manchester, the latter which was managed by Mr. King's wife, Clarrine (May) King. The collection also comprises business documents created by Mr. King's father-in-law, A. M. May, while owning and operating the May Lumber Co. in Manchester in the early half of the 1900s. Other items in the collection include certificates, correspondence, court records, estate papers, legal documents, and photographs.

The materials were donated by Mr. Charles Lapidus of Nashville, Tennessee. Mr. Lapidus's late wife, Melba, was a niece of Dave King.

The materials in this finding aid are originally measured approximately 30 cubic feet when accessioned, but were reduced to 15 cubic feet by the removal of numerous cancelled checks and bank statements. There are no restrictions on the material. Single photocopies of unpublished materials in the David King Papers May be made for individual or scholarly research.

SCOPE AND CONTENT NOTE

The David King Papers, containing approximately 700 items, span the period 1901-1978, although concentrated between 1940-1970. The collection is composed of account books, accounts, certificates, clippings, contractor/architectural specifications, correspondence, court records, diaries, estate papers, farm records, financial documents, genealogical data, insurance papers, land records, legal documents, licenses, obituaries, photographs, school records, tax records, writings, and some miscellaneous documents.

A major portion of the collection consists of land records (abstracts of titles, plats, and surveys, etc.) of farm lands in Coffee County and lots and subdivisions in Manchester which Dave and Clarrine King were involved in purchasing and/or selling. Along with their ownership of several businesses in Manchester, they were by the 1960s considered as one of the wealthiest citizens in Coffee County. Their English Tudor style home in Manchester, which was built by Clarrine's father, A.M. May in 1923, was considered for many years as the showpiece of Manchester homes. In the collection are the architect/contractor plans and specifications for the building of this residence (see Box 3, Folder 38 and Box 32, Folder 1) and several photographs of this magnificent home may be found in Box 27, Folder 8.

David King, along with three of his brothers, emigrated to the United States from Russia in the early twentieth century. Overcoming a lack of formal education and the common hostility that many Americans had toward foreigners, the King brothers, through their perseverance and business acumen, became an American success story. The David King Papers represent an important written record of one family in Coffee County, Tennessee.
