INTRODUCTION

This finding aid focuses on the Addition to the papers of David (Dave) King, businessman and extensive landowner, of Manchester, Coffee County, Tennessee. Although spanning the years 1961-1996, the papers are largely concentrated around Mr. King in the period 1985-1990. Mr. King was adjudged incompetent by the court in 1985 and his business affairs were placed in the hands of a conservator until his death in 1990.

The collection largely consists of financial documents and tax records during the later years of Mr. King's life. Included in this addition of the David King Papers are court records relating to the attempt by the conservator to recover monies which Mr. King had loaned during the declining years of his life.

Like the original collection of the David King Papers (Accession Number 1996.096) the materials were also donated by Mr. Charles Lapidus of Nashville, Tennessee, whose late wife, Melba, was a niece of Dave King.

The materials in this finding aid originally measured approximately eight cubic feet when accessioned, but were reduced to four cubic feet by the removal of numerous cancelled checks and bank statements. There are no restrictions on the materials. Single photocopies of unpublished materials in the David King Papers—Addition may be made for individual or scholarly research.

SCOPE AND CONTENT NOTE

The David King Papers—Addition, containing approximately 675 items, span the period 1961-1996, although concentrated between 1985-1990. The collection is composed of bills, notes and receipts, court records, estate papers, financial documents, land records, legal documents, and tax records.

The bulk of the collection consists of financial documents and tax records. The financial documents is largely comprised of ledger sheets listing expenses, income, payroll sheets, and promissory notes.

Tax records are divided into income returns and real estate bills and receipts. Mr. King had extensive holdings of real estate in Manchester, Tennessee, as well as farm land in Coffee County.

An interesting part of the collection was the attempt by the conservator of Mr. King to recover payments of outstanding notes (see Box 1, Folder 3 and 4).
