Scope & Content:

The Montgomery Family Papers spans the period 1800-1982. The collection is comprised of accounts, Civil War documents, letters, court records, deeds, genealogy, and receipts concerning James Montgomery of Davidson County, Tennessee. The collection contains several Davidson County tax receipts and accounts showing purchases of clothes, dry goods, and farming tools for James Montgomery. There are several deeds for land being purchased by James Montgomery in Davidson County, as well as a deed for Indian land in Oklahoma being purchased by Mrs. R. R. Carmack of Nashville, Tennessee, in 1917. The collection contains correspondence between I. R. Schulman, a lawyer in Nashville, and Nadolyn Yalovitz, a dress shop owner in Memphis, concerning family and friends related matters. There is a will for Stirling M. Brown of Marshall County, Tennessee, and a Davidson County Public Schools Annual Report, which includes lists of board members, white and colored teachers, courses studies, general statistics, and public school conditions.

There is a court record, dated 1829, that rules in favor of James Montgomery against John Stobaugh, Henry Cassels, and William Reynolds in the sum of \$38.67. The collection also holds some genealogy on the history of the Montgomery name and several photocopies of Civil War documents concerning Mrs. William Cooper. Included in these documents is a correspondence addressed to Brig. Gen. McCook, giving Mrs. William Cooper permission to go to Murfreesboro, Tennessee, and retrieve her child along with two other individuals, but orders her not to converse with the army.
