INTRODUCTION

The papers of Owen McGarr (1835-1906) – lawyer, private soldier in Captain Green's Company (Louisiana Guard Battalion) Louisiana Artillery, Consul-General of the United States to Ecuador (1885-1886), Secretary of Legation at Santiago, Chile, (1893-1895), Consul at Cienfuegos, Cuba (1895-1898) – and, the papers of Shelah Waters – Major in General W.B. Stokes' Cavalry (First Middle Tennessee Cavalry), Clerk in the Office of the Second Auditor of the Treasury (1868-1869), Assessor of Internal Revenue in Third Collection District of the State of Tennessee (1871-1875), and postmaster at Lebanon, Tennessee (1875) – were given to the Manuscript Section by Mr. Vincent Waters of Washington, D. C. through the agency of Mr. Fred Estes.

Linear feet of shelf space occupied by materials in this finding aid are 1 portfolio, 20 inches X 15 1/2 inches.

Literary rights in the McGarr-Waters Papers have been dedicated to the public. Single photocopies of unpublished writings may be made for purposes of scholarly research.

SCOPE AND CONTENT

The McGarr-Waters Papers, containing approximately 50 items, span the period 1848-1903. The collection is composed of correspondence, licenses to practice law in several states and several courts, certificates of appointment to several diplomatic positions, and exequaturs from the various foreign governments to which Owen McGarr was appointed. These licenses and diplomatic papers of Owen McGarr, a native of Mississippi who lived in Washington, D. C., Colorado, Ecuador, Chile and Cuba for the greater part of his life, are for the years 1861-1898. He retired to Chattanooga, Tennessee and was living there at the time of his death.

In addition to the McGarr Papers, there are about ten items of Shelah Waters, a native of Tennessee and a relative of Owen McGarr by the marriage of his sister. Shelah Waters was a Federal soldier and was appointed to a clerkship in the Internal Revenue Service in Tennessee in 1868. In 1875, Grant appointed him postmaster at Lebanon, Tennessee. These papers and correspondence relate to these appointments and are for the years 1868-1875.

Owen McGarr

- ca. 1838 Born in Vicksburg, Mississippi
 Attended School in Mississippi
- 1853 Appointed Clerk in General Land Office, Washington, D. C.
- 1861 Admitted to bar in Washington, D. C.
- 1861-1865 Served in Confederate Army – Captain Green’s Company (Louisiana Guard Battalion) Louisiana Artillery
- 1873 Licensed as an attorney and counselor of the Supreme Court of the United States
- 1878 Licensed to practice as counselor at Law, Solicitor in Chancery and Proctor in Admiralty of the District Court of the United States for the District of Colorado at Denver
- 1880 Licensed as Attorney and Counselor at Law in the Supreme Court of Colorado
- 1880 Licensed to practice in the Circuit Court of the United States in the District of Colorado
- 1885-1886 Appointed Consul General of the United States to Ecuador
- 1893 Appointed Secretary of the Legation at Santiago, Chile
- 1895-1898 Appointed U. S. Consul at Cienfuegos, Cuba
- 1898 Ordered to leave Cuba just prior to the outbreak of Spanish-American War
- 1906 Died in Chattanooga at sixty eight years of age

- ca. 1838 Born. Wilson County, Tennessee
- 1861-1865 Major in Stokes' Cavalry (First Middle Tennessee Cavalry)
- 1868-1869 Clerk in Office of the Second Auditor of the Treasury
- 1871 Assessor of Internal Revenue in Third Collection District of the State of Tennessee
- 1875 Appointed postmaster at Lebanon by U. S. Grant
- 1894 Died February 2, living in Nashville, Tennessee at time of death
