INTRODUCTION

The Marshall Tate Polk Family Papers, 1826-1981, are centered around the Marshall Tate Polk family of Bolivar, Hardeman County, Tennessee. The papers are on deposit by Mrs. Joe Bowman, Franklin, Tennessee.

The materials in this collection measure .42 cubic feet. There are no restrictions on the materials.

Single photocopies of unpublished writings in the Marshall Tate Polk Family Papers may be made for purposes of scholarly research.

Mrs. Bowman reserves the right to first publication of materials in this collection.

SCOPE AND CONTENT

The Marshall Tate Polk Family Papers, approximately 84 items, spans the period 1826 to 1981. The collection centers around the Marshall Tate Polk family of Bolivar, Hardeman County, Tennessee and includes clippings, correspondence, envelopes, genealogical data, land records, legal documents, military orders and photographs.

The bulk of the collection is comprised of correspondence. The majority of the correspondence is war letters from Marshall Polk to his wife and his father-in-law, Major John H. Bills. These letters give good descriptions of the Far West in the 1850s and details of the infamous Sioux Expedition of 1855. There are several letters from his wife, Eva Bills Polk to Marshall Polk, as well as from Sarah Childress Polk, widow of President James K. Polk, concerning her nephew's capture and release from Johnson's Island Prison. There is some correspondence from Wilson Bills, Eva Bills Polk's brother; one to Clara Bills, Eva Polk's sister; and one letter from Confederate General Leonidas Polk.

Other items in the collection include an indenture (deed) and power of attorney for Marshall Tate Polk, and photocopies of family photographs and notes made by Mrs. Joe Bowman concerning family members.

For further genealogical information the researcher may consult the G.B. Howard Papers, located in the Tennessee State Library and Archives.

The Marshall Tate Polk Family Papers are an important avenue for the study of a prominent family and more generally for antebellum Southern life and culture.

BIOGRAPHICAL SKETH

Marshall Tate Polk

May 15, born in North Carolina, the son of Marshall T. Polk (1806-1831) and Laura T. Wilson Polk 1852 Was graduated from United States Military Academy at West Point, New York 1852 Entered U.S. Army as a Second Lieutenant in the Second Infantry 1852-53 Was on frontier duty at Rancho de Jampa, California 1853 Was shipwrecked off the coast of Acapulco 1853 Was stationed at For Miler, California 1854 Stationed at Fort Riley and Fort Leavenworth, Kansas Aide-de-camp to Bvt. Major-General Twiggs 1854-56 Participated in the Sioux Expedition and was present at the Battle of Blue Water, 1855 September 3, 1855 1856 April 10, resigned from U.S. Army 1856 January 10, married Evalina McNeal Bills, daughter of Major John H. Bills and Prudence Tate McNeal Bills. The marriage took place at "The Pillars", the home of Bills in Bolivar. 1856-61 Pursued farming life on his plantation in Hardeman County Autumn, a captain of Polk's artillery in the Confederate Army. Was in the Battle of Belmont at Columbus, Kentucky 1862 April, fought in the Battle of Shiloh, where he was wounded and later lost his leg 1878 The Polk family moved to Nashville

1884 Died in Nashville and was buried in the Polk Cemetery in Bolivar, Tennessee
