INTRODUCTION

The Ragland Family Papers collection is centered on the Ragland family of Haywood County, Tennessee. Included in the collection are correspondence, genealogical data on the Ragland family, and some speeches of Governor John Marshall Stone, Governor of the State of Mississippi. The donor of this collection is Miss Martha Ragland, Brownsville, Tennessee

The material in this finding aid occupies .42 linear feet of shelf space. Literary rights to the papers in the Ragland Family Papers collection have been dedicated to the public. Single photocopies may be made for purposes of scholarly research.

SCOPE AND CONTENT

The Ragland Family Papers Collection, containing approximately 64 items, spans the period 1861-1899. This collection is centered on the Ragland family of Haywood County, Tennessee, whose primary correspondents were John Marshall Stone (1830-1900), Governor of the State of Mississippi (1876-1881. 1890-1896) and Thomas Fletcher Ragland (1842-1863), a Haywood County native who fought in the Confederate Army and died from wounds received at the Battle of Chickamauga (1863). Also included in the collection is genealogical data on the Ragland family and some speeches of Governor Stone.
