## **INTRODUCTION**

The Albert Houston Roberts Papers (1859-1938) are centered around the law career of Albert Houston Roberts, Nashville, Tennessee. Donor is unknown. The collection occupies 25.20 cubic feet of shelf space, and numbers approximately 9000 items and one volume. Single photocopies of unpublished writings in the Albert Houston Roberts Papers may be made for purposes of scholarly research.

## BIOGRAPHICAL SKETCH

### Albert Houston Roberts

- 1868 July 4, born in Alpine, Overton County, Tennessee, the son of John Allen and Sarah Emaline Carlock Roberts
- 1874-1881 Educated in Overton County schools
- 1881 Removed with his family to Kansas
- 1881-1886 Educated in elementary and secondary schools in Columbus, Kansas
- 1886-1889 Attended Hiwassee College at Sweetwater, Tennessee and graduated with a Bachelor of Arts degree
- \_\_\_\_\_ Awarded a Master of Arts degree from Hiwassee College
- 1889 May 16, married Nora Deane Bowden, daughter of Professor Bailey Owen and Molly Sproul Bowden
- 1889-1894 Teacher and, later, President of Alpine Institute in Madisonville, Tennessee
- 1894 Admitted to the bar in Tennessee to practice law
- 1894-1910 Legal practice in Overton County
- 1896-1901 Served two terms as Overton County's superintendent of public instruction
- 1910-1918 Chancellor of the Fourth Judicial Division of Tennessee
- 1914 Unsuccessful candidate for Democratic nomination for Governor
- 1919-1921 Governor of Tennessee
- 1920 Defeated by Alfred Taylor in his bid for re-election
- 1921-1925 Practiced law in partnership with James W. Cooper in Nashville
- 1925-1946 Practiced law in partnership with his son, Albert Houston Roberts, Jr., in Nashville
- 1946 June 25, died in Nashville and interred in Good Hope Cemetery, Livingston, TN

## SCOPE AND CONTENT NOTE

The Albert Houston Roberts Papers, containing approximately 9000 items and one volume, span the period 1859-1938, although the bulk is largely concentrated in the years 1921-1935. The collection is composed of account books, accounts, associations, institutions, etc., Civil War claims, correspondence, court records, a day book, estate papers, farm management papers, invitations, programs, etc., land records, legal records, school records, speeches, addresses, etc., and several miscellaneous items.

Court record cases make up the main body of the collection. Albert Houston Roberts (1868-1946) pursued a legal career in Livingston, Tennessee before being elected governor in 1918. Following his term in office (1919-1921), he reestablished his law office in Nashville and was in partnership first with James W. Cooper between 1921-1925 and later with his son, Albert Houston Roberts, Jr. (1900-1950). During these years several other attorneys were associated with the Roberts law firm including John T. McCall, Allen W. McComb, T. T. McCarley, H. W. Fenker, S. E. Wasson and W. W. Mann. There are 1166 court cases in the collection covering a wide range of litigation: divorces, estates, liability claims, public utilities rate cases, bankruptcies, and collection cases. Normally each court record contains a plaintiff's bill of complaint or declaration, an answer by the defendant, depositions, a decree or order, and correspondence relating to the case. In several cases the decision of the lower court was appealed to higher levels. Among the more important cases are the Cumberland Telephone and Telegraph Co. rate case and the Brier Hill Collieries case involving a large tract of land in Fentress county.

Accounts have been divided into farm, household, office and promissory notes. Governor Roberts owned land in both Overton and Davidson counties. There are many personal promissory notes as well as notes in which Roberts was a surety. In several instances Roberts was liable for the settlement of those promissory notes when the borrower failed to make good on the maturity date.

Roberts as an attorney was engaged to represent several Civil War claimants who had lost property during that conflict. These are arranged in the Container List as "Civil War--Claims."

Correspondence is arranged under the following sub-headings: family, general/legal, and political. Among the prominent political correspondents are Cordell Hull (1871-1955), Huey Long (1893-1935), and Kenneth McKellar (1869-1957). It was a practice of Governor Roberts to type the copy of his replies on the back of his incoming correspondence.

Although Governor Roberts served only one term he maintained an active interest in Tennessee politics as reflected in his extensive correspondence with residents of his state. His outgoing political correspondence is replete with his frank feelings expressed toward such contemporary politicians as Austin Peay (1876-1927), Henry Horton (1866-1934), Luke Lea (1879-1945), Hill McAlister (1875-1959), and Lewis Pope (1878-1972).

Due to a profitable legal career Governor Roberts was able to purchase in 1927 a large tract of land on McGavock Pike in east Nashville. The "Farm Management" file (bx. 57, f. 1) contains correspondence relating to the operation of this farm.

Among the invitations, programs, etc., are invitations to the governor's inauguration of Albert H. Roberts in 1919 and for Hill McAlister in 1933. Included in the school records are several

loose records of the Alpine Institute (Bowden-Roberts School) in 1890-1891. Among the miscellaneous items is a catalog for the Frank School of Music (Nashville, Tenn.) for 1926-1927 and the charter and correspondence pertaining to the Alvin C. York Agricultural Institute, Jamestown, Tennessee.

The Albert Houston Roberts Papers supplement the earlier collection of the Governor Albert Houston Roberts Papers in the Tennessee State Library and Archives.

Note:

The unprocessed Albert Houston Roberts Papers were stored for several years in the attic of the former governor's home on Freno Lane in what is now Donelson, Tennessee. Sometime in the mid-1950s these papers were acquired by the Tennessee State Library and Archives. Due to the exposure to light and lack of humidity and temperature control while in storage before their transfer, considerable work (cleaning, trimming, and photocopying) was necessary in preparing this collection for researcher use. Due to their age and years of neglect many of the papers still remain in fragile condition.
