# Rose Family Genealogical Collection, 1778-2008

#### **COLLECTION SUMMARY**

#### **Creator:**

#### **Scope & Content:**

Consists of genealogical data regarding the Rose Family of Ballard and Carlisle counties in Kentucky. This collection holds numerous photocopied deeds, indentures, church records, census records, as well as correspondence, photographs, negatives, tintypes, photograph albums, diaries, and funeral guest books. Unfortunately, the majority of the photographs, negatives, tintypes, and both of the photograph albums are unidentified; one might assume they are of the Rose family and perhaps other related family members. There are also some photographs of cemeteries showing Rose family headstones in Box 3, f. 9 and Box 7, f. 2. Correspondence of note include letters from the California Gold Rush sent by Gramberry Rose to his wife, Mary Sublett, and family in Greene County, Missouri, dating from 1850 to 1855. The transcribed letters are in Box 1, f. 8.

The three diaries belonged to Elise Lucile Rose for the years 1966-1968 and detail her daily life and activities. Also included are the photocopied minutes of the Hopewell Baptist Church in Arlington, Kentucky, dated September 1881-January 1902, excluding March 1908-August 1911. The negatives for these photocopies are located in Box 6, f. 1. The researcher also included a small variety of Rose genealogy from Arkansas, Missouri, Tennessee, and Texas.

Series III constitutes a later addition and contains James H. Rose's genealogical research materials related to the Rose family.

# Administrative/Biographical History

It should be noted that little biographical history could be located concerning Bob Rose or his immediate family. Therefore the information provided below was culled from the collection itself. It is believed that this collection follows the descendants of James Madison Rose and his wife, Louise Elizabeth (Adams) Rose. It also seems likely that James Harrison Rose was the primary compiler of these records.

James Madison "Matt" Rose and his wife, Louise Elizabeth (Adams) Rose, moved from Henry County, Tennessee, to Carlisle County, Kentucky, in 1848. They had several children; their seventh child was James Henry Rose. He was born on August 28, 1867, in Carlisle County and married Lizzie Ann McMurry from the same county. James and Lizzie had several children as well. Their seventh child was James Paul Rose. He was born on May 16, 1908, and he married Ophia Rye, of Ballard County, Kentucky. They had four children: James Harrison Rose of Nashville, Tennessee; Wanda Lee Rushing of Clinton, Kentucky; Bobby Kenneth Rose of Severn, Maryland; and Michael Paul Rose of Houston, Texas.

## **SERIES III. – Additional Genealogy Materials**

Series Scope and Content: This series consists of James H. Rose's correspondence with other genealogical researchers of the Rose family. This correspondence includes emails, genealogical tables, photographs, and additional research files. Various materials contain accounts for the Rueben Rose Cemetery restoration project, dated 1998 to 2000; certificates for Paul Rose, dated 1920 to 1921; photographs of the Rose family, dated 1912 to 1963; and a scrapbook of the Rose family, dated 1913 to 1919. Family Tree Maker Materials, dated 1993 to 2006, holds software manuals, handwritten notes, and correspondence by James H. Rose. Oversize materials contain a handwritten genealogical table, undated, by Paul W. Rose and a map of Robertson County, dated 1995. Restricted folder includes James Paul Rose's employment contracts, dated 1951 to 1964; social security card, dated 1937; driver's license, dated 1993; and copy of a death certificate, dated 1992. Vault materials contain six compact discs, dated 2006 to 2008, with inaccessible Family Tree Maker data in proprietary file format.
