### **INTRODUCTION**

The Simerly Family Papers (1857-1954) are centered on the Simerly Family of Johnson City, Tennessee. The Simerly Family Papers were a gift of the Tennessee Historical Commission of Nashville, Tennessee.

The materials in this collection measure 1.68 cubic feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the Simerly Family Papers may be made for purposes of scholarly research.

#### SCOPE AND CONTENT

The Simerly Family Papers, containing approximately 1,000 items, span the period 1857-1954. The collection is composed of account books, accounts, receipts, cards, certificates, clippings, correspondence, income tax records, legal documents, printed materials, school records, and several miscellaneous items.

The Simerly family, closely related to the Taylor family, were prominent citizens of East Tennessee, and the correspondence, which comprises the bulk of the collection, is concerned with the varied business interests of the family. The remainder of the correspondence is family related. The account books and receipts deal with the daily operations of the family mercantile establishment located in Johnson City, Tennessee. The school records of Lawson G. Simerly are composed of grade reports and final examinations. Printed materials include a large assortment of postal and greeting cards, clippings, booklets, and bulletins. The World War II Rationing Coupon books are particularly interesting to the researcher.

The Simerly Family Papers provide an interesting view of a prominent East Tennessee family from the time after the Civil War to the 1950s. Although there is little genealogical information in the collection, it may hold some interest for the social historian.
