SCOPE AND CONTENT

Subjects of special interest constitute the bulk of the records of the Office of the Attorney General and Reporter, supplemented by some items of a routine nature. The acquisition of land for the Great Smoky Mountains National Park is documented in detail. Scrapbooks, ledger sheets, and statements described the Horton-Crump political battle of 1921. Investigations prompted by the financial crises of the early Depression years and plans for the institution of the Social Security program are also documented here. The work of the office on legislation for the General Assembly is reflected in a portion of the records.

Routine records include a small amount of correspondence and opinions of the Attorney General from 1899 to 1912.
