An act of the State Legislature created The Board of Examiners in Psychology in 1953. Its mission is to safeguard the health, safety, and welfare of Tennesseans by requiring those who practice as psychologists or psychological examiners within this state to be qualified. The Board interprets the laws, rules, and regulations to determine the appropriate standards of practice in an effort to ensure the highest degree of professional conduct. The Board is authorized to issue licenses to qualified candidates who have graduated from approved schools, completed appropriate post graduate work, and passed the examination administered by the Board. The Board is responsible for the investigation of alleged violations of the Practice Act and rules and is responsible for the discipline of licensees who are found guilty of such violations.
