## **SCOPE AND CONTENT NOTE**

Record Group 219 consists of the financial disclosure reports submitted to the Tennessee Secretary of State's Office by candidate for the State Legislature, Public Service Commission, State Judicial Offices and for Tennessee Governor. These records encompass the years 1980 through 1989, however there are loose files of clients dates 1974 and 1978. Disclosure reports for State Political Action Committees are also included within these records. These records were received from the Secretary of State's Office filed in Chronological order, and have been processed in much the same order.
