## SCOPE AND CONTENT NOTE

Record Group 42, Secretary of State, Charters of Incorporation, contains materials spanning the years 1875-1977. The record group consists of Charters of Incorporation for Tennessee companies; these records span the period 1875-1957. Index volumes cover the larger period of 1875-1977. Also included in the collection are the reports filed annually by Tennessee companies and companies conducting business in Tennessee that have applied for a certificate of authority to operate in Tennessee.

Although Tennessee does not require companies to be chartered in Tennessee, businesses headquartered in the state generally request a charter. Charters are requested and granted to provide legal protection for business owners and agents. A chartered company's owners and agents are free from personal liability in the event the company is challenged by a lawsuit in court. In addition, no other company may use the business name of a company already chartered.

Businesses headquartered outside Tennessee may request a certificate of authority, which is known as a "foreign charter" in order to conduct business within the state. Charters of Incorporation include such information as type of business, method of nominating a board of directors and the board's duties if so required, name of their registered agent in Tennessee and other types of legal information.

Whenever a chartered company is dissolved, the charter is surrendered to the Secretary of State. Series VI consists of charters of Tennessee companies that have been surrendered. Organizations headquartered outside Tennessee may elect to cease operation in Tennessee by withdrawing their charters. Series VII contains withdrawal volumes of foreign charters.

This record group contains only domestic charters. Foreign charters appear in microfilmed Record Group 281, Secretary of State, Foreign Charters, 1874-1971.

### **SERIES DESCRIPTIONS:**

Series I consists of the indexes to domestic charters in Tennessee. These indexes are for the domestic charters, amendments to charters and charters that have been surrendered. Series I, Indexes to Domestic Charters (microfilmed); microfilmed Record Group 227, Secretary of State, Charters of Incorporation Name Index Card Files, 1875-1978; or the Business Information Search tool on the Secretary of State Division of Business Services web site may be used to generate charter volume references for domestic charters found in Series IV. Series II does not have an index with the microfilmed annual reports. The Business Information Search tool provides references to extant annual reports and other corporation documents for entities that may be obtained through the Division of Business Services. The Record Group 227 index cards supply numbers for locating domestic and foreign annual reports on the Series II microfilm and on additional microfilmed annual reports in Record Group 242, Secretary of State, Domestic & Foreign Corporations Annual Reports, 1927-1975. In addition, the cards of Record Group 227 convey references for amendments to charters and charter surrenders and withdrawals. Record Group 242 addresses some of the gaps found in Series II that reflect missing volumes of annual reports.

Series V contains a few volumes dedicated to special types of charters for military companies, towns, turnpikes, reincorporations, and credit unions. None of these “specialty” charter volumes had sustained usage; they each represent a limited period of time.
