INTRODUCTION

The records contained in Record Group 48, Department of Insurance and Banking, span the period 1916-1966, although the bulk of the collection is concentrated in the period 1932 through 1952. The record group consists of correspondence, reports and subject files.

The Department of Insurance and Banking, whose duties are now performed by the Department of Commerce and Insurance and the Department of Financial Institutions was created by act of the Tennessee General Assembly in 1914. Its responsibility was the supervision and regulation of insurance companies, banks, investment companies, building and loan associations, and small loan agencies. Its primary aim was the protection of the public against mismanagement, fraudulent representations, insolvency, sharp practices and speculation in businesses under its control. Another important function of the department was the collection of fees, taxes, and licenses from the companies supervised and from insurance agents.

This department consisted of five major divisions: the Division of Insurance, the Division of Banking, the Blue Sky Division, the Building and Loan Division, and the Division of Fire Prevention. While the Division of Banking was made a part of the department by law, it was to a considerable extent a separate agency.

The records contained in this collection came to the Tennessee State Library and Archives through the State Records Center. The final disposition of the record group was determined by the Records Disposition Authorization (RDA) process. In accordance with the RDA, all material in Record Group 48 has been microfilmed and the originals were disposed of by state approved methods.

Record Group 48 consists of approximately 7 cubic feet. In accordance with the RDA some materials were sampled, while others, including duplicate copies and routine office materials were disposed of during processing. State publications were removed and added to the library holdings.

Researchers may wish to consult other holdings in the Tennessee State Library and Archives concerned with the Department of Insurance and Banking. Record Group 177 includes material from the Examination Sections and the Loans and Securities Section.

SCOPE AND CONTENT NOTE

Record Group 48, the Department of Insurance and Banking, spans the period 1916 through 1966. The collection consists of approximately 7 cubic feet of material. In accordance with the Records Disposition Authorization (RDA), the collection was microfilmed and the originals were destroyed.

The collection is composed of correspondence, investigations of suspected arson, and subject files. The correspondence is general in nature, and is concerned with routine inquiries sent to the Commissioner of the department. The largest amount of correspondence is from Albert Williams, who served as Commissioner in the late 1960s. There is very little correspondence in the collection before 1930.

The bulk of the collection consists of subject files. The subject files corresponded to the various activities of the department. The subject files are arranged in alphabetical order, and may include correspondence, handwritten notes, and other materials. The arson investigation files include testimonies from the accused and witnesses. Each file has a final report issued by the investigator. They are arranged in alphabetical order.

Record Group 48 may be beneficial to the researcher if used in conjunction with other record groups dealing with the Department of Insurance and Banking, although used singularly the material is routine in nature.
