## Administrative/Biographical History

State government's role in tourism has come a long way since its beginning in 1936 as a small division of information under the Department of Conservation. In 1972, the Tourism Division settled under the newly formed Department of Economic and Community Development. The Tennessee Department of Tourist Development became the first cabinet-level department of tourism in the United States in 1976. The commissioner's office provides direction for all department operations. Reporting directly to the commissioner are the Administrative Services, Outreach and Engagement, and Marketing divisions, the legislative liaison, as well as the system of Tennessee Welcome Centers.
