## INTRODUCTION

This Addition to Record Group 242, Secretary of State, Division of Services, Domestic & Foreign Corporation Annual Reports, 1964 – [1975-1977] – 1977, contains 25 cubic feet of annual reports filed by corporations. These forms were maintained by the Department of Revenue until 1983 according to information received from the Division of Business Services. The forms were filed to accompany the franchise, excise tax returns. The majority of the forms are arranged numerically but some are alphabetical. The original arrangement used by the Department of Revenue was retained although some users will find the system cumbersome. It must be said that the arrangement and maintenance of these records was poor. Large gaps in the numbering sequence due to missing reports are indicated in the Container List. Some missing reports may be found in Record Group 42, Secretary of State, Charters of Incorporation, 1875-1966 and Record Group 242, Secretary of State, Division of Services, Domestic & Foreign Corporation Annual Reports, 1927-1975.

This addition also contains about 2 ¼ cubic feet of Certificates of Authority for 1969 and 1971. They are arranged in alphabetical order.

This record group was microfilmed and the originals disposed of according to the Tennessee State Records Disposition Authorization #1678. This is a microfilm only collection. There are no restrictions on the use of the materials in this collection.

## SCOPE AND CONTENT

This addition to Record Group 242, Secretary of State, Division of Services, Domestic and Foreign Corporation Annual Reports, contains about 25 cubic feet of documents spanning the years 1964 through 1977, although the majority of documents span the years 1975 through 1977. These documents were generated before 1983 when the Department of Revenue maintained these records. The Secretary of State, Division of Business Services, currently maintains these types of records. This addition consists of annual reports filed by corporations headquartered in Tennessee, known as Domestic Corporations, and those doing business in Tennessee but headquartered outside the state, known as Foreign Corporations. The annual report is a form that accompanies the franchise, excise tax return. Certificates of Authority for 1969 and 1971 are also included in this addition.

Large gaps in the numerical files are indicated when possible in the Container List. However, the Foreign & Domestic Reports, 1976-1977, in boxes 2 through 4 have an average of one in every ten documents missing. The Domestic Annual Reports for 1976 in box 5 contain a large gap of missing documents between numbers 1801 through 5000 and 6849 through 7551 in Box 6. The Foreign Reports for 1976 in Box 23 also have a large gap between numbers 4267 and 24,426. This last sequence of numbered documents ends at 24,438. There is also a gap in the alphabetical files from R-S in Box 19 of Foreign and Domestic Reports for 1977.

The Department of Revenue was not consistent in separating the Domestic Reports from the Foreign Reports in 1976 and 1977. The reports are sometimes filed together and sometimes separately. Be sure to check the container list thoroughly for both listings.

It is not known if an index to the numbered documents still exists today. It may be possible that the numbered documents related to a numbered receipt issued for the payment of a fee related to the filing of these documents. The Division of Services under the Secretary of State maintains these types of records today in numerical order and that system, when found, has been maintained in this collection.

Additional information may be found in Record Group 42, Secretary of State, Charters of Incorporation, 1875-1966 and Record Group 242, Secretary of State, Division of Services, Domestic & Foreign Corporation Annual Reports, 1927-1975.
