SCOPE AND CONTENT NOTE

Record Group 169, Tennessee Office of Child Development, spans the period 1969-1980. The group consists of budget documents (contracts, financial statements, grants), correspondence, legislative material, meeting agendum and minutes, personnel (goals and objectives, job descriptions), printed materials, reports, and statistical data.

The Tennessee Office of Child Development was in existence from 1970-1980. The initial responsibility of this office was the administration of the Appalachian Regional Commission's Child Development Program. The Child Development Act of 1974 created an Office of Child Development within the Office of the Governor, Office of Urban and Federal Affairs, with state-wide responsibilities.

The primary function of the office was the coordination of programs for children under six years of age and their families. At the state level the legislation provided for a policy committee of commissioners of the departments providing services to children and families, and interdepartmental committee which met monthly to implement policy, and a state-wide advisory committee.

At the regional level there were regional child development coordinators who were responsible for the formation of local and regional child development councils. These councils were responsible for advisement to the Office of Child Development and the Policy Council of the needs and priorities of the regions.

The staff of the Office of Child Development was responsible for developing a state plan for child development, for providing technical assistance to programs for children under six, for coordinating programs for children, and for reporting to the Governor and the Legislature on child development programs.

The Appalachian Regional Commission funds administered by the office were used for a variety of programs aimed at making it possible for children to achieve their full potential. These projects ranged from infant intensive care to day care, with the largest investment in a comprehensive home-based child health and parent education program in fifteen counties.

On July 1, 1980, the Office of Child Development was abolished and all records and functions were turned over to the Tennessee Children's Services Commission.
