SCOPE AND CONTENT NOTE

Record Group 95 consists of the Executive Orders from the following Tennessee Governors: Frank G. Clement (1953-1955; 1956-1958; 1963-1966), Buford Ellington (1959-1962; 1967-1970), Winfield Dunn (1971-1974), Ray Blanton (1975-1978), Lamar Alexander (1979-1986), Ned Ray McWherter (1987-1995) and Don Sundquist (1995-2003). Executive Orders allow the Governor of the State to have a more direct role in the policy-making process of State Government. Questions have been raised concerning the Governor's constitutional power to issue such orders. Article III, Section I of the Tennessee Constitution (1870) states that "the Supreme Executive power of this State shall be vested in a Governor." The Supreme Court has stated that executive power is the authority to administer and enforce the law. The State Constitution fails to give a specific definition of executive powers.

Executive Orders deal primarily with appropriations, creation of state agencies, appointments, etc. Very rarely does the Executive issue and order activating the Tennessee National Guard.
