INTRODUCTION

Record Group 290, Political Action Committee Registrations, Registry of Election Finance, 1994-1996, Addition, contains the reports of political action committees that by law are filed with the State Registry of Election Finance. These records measured 28 cubic feet and were maintained by the State Registry of Election Finance, a division of the Secretary of State. The records were received directly from the State Registry of Election Finance and were in good condition. There are no restrictions on the use of these records.

The files have been microfilmed and the originals disposed of according to State RDA #453.

SCOPE AND CONTENT

The State Registry of Election Finance is the agency that is responsible for the enforcement of Tennessee's Campaign Financial Disclosure laws. The registry was created in 1989 as an independent entity and attached to the Department of State for administrative purposes. The seven member board is appointed by the governor and the General Assembly.

The files in this record group contain the reports and correspondence of political action committees from 1994-1996, as they were received by the registry. Reports are required of any multicandidate political campaign committee, popularly known as a PAC, that participates in any state or local election. "Multicandidate committee" is defined as a committee that makes expenditures to support or oppose two or more candidates for public office or two or more measures in referenda elections. The files are arranged chronologically then alphabetically. The files contain all reports and correspondence of the political action committee for the given year. The original order was strictly maintained during processing and no documents were discarded. There are no chronological gaps within the materials. Additional PAC records for 1990-1993 can be found in the earlier processed Record Group 290.

Information concerning rules and regulations for financial disclosure can be found in *Tennessee Manual for Campaign Financial Disclosure* prepared by the Tennessee State Library and Archives in 1976, *Campaign Financial Disclosure Guidelines* prepared by the Tennessee Registry of Election Finance in 1994, and *Campaign Financial Disclosure Statement Instructions and Forms* prepared by the Tennessee Registry of Election Finance in 1997.
