SCOPE AND CONTENT

In 1973 Senate Bill #160, House Bill #208 and House Bill #170, and Senate Joint Resolution #'s 23-28 were passes as a result of the Tennessee Senate Commission on Child Dependency, Neglect and Abuse's efforts to tighten the laws regarding these areas. Records of the Commission are complete and fully document its work. Transcripts of the Advisory Committee meetings, committee and staff reports, correspondence, published booklets, and copies of the adopted laws are included.

The Committee's transcripts of its meetings, and the staff's reports are valuable sources for an in depth understanding of the problem of cruelty to children. Several case histories are described as are the legal problems of immunity from libel for the individual reporting cruelty to children, court removal of children from their parents, the failure of those who mistreat children to avail themselves of counseling and treatment, and the excessive requirement of proof of mistreatment.

Following the folder description of the series is an index showing subjects found within the record group.
