The Department of Commerce and Insurance's Regulatory Boards Division regulates several hundred thousand Tennesseans in their professions and businesses. These boards, commissions and programs have the power to take disciplinary action—including revocation of licenses and assessment of civil penalties—against license holders found guilty of violating laws governing their professions, and have a separate investigations unit. The Commissioner of Commerce and Insurance appoints members of the Soil Scientists Licensing Program. The purpose of the Tennessee Professional Soil Scientists Licensing Program is to ensure that only qualified persons are licensed to practice soil science in Tennessee, thereby benefiting the safety, health, and property of the people of this state and promoting the public welfare.
