SCOPE AND CONTENT

The bulk of the Supreme Court Building Construction Records consists of Construction and Maintenance Correspondence of the years 1935 through 1942. Included in this Record Group are specifications covering the materials used in the building, final finishes, and furniture schedules.

Financial data is regulated to estimates of construction costs and payments made from 1936 to 1942 as work on the project progressed. There are some bids, particularly for furnishings, as well as on folder devoted to expenditures for the period April, 1936 to December, 1938.

The minutes to the Tennessee Supreme Court Building Commission are in typed and bound form and located in Box 2. Blueprints and Architectural Detail Drawings are located in the Map Drawers in the Search Room.
