INTRODUCTION

The records contained in Record Group 317, Tennessee Commission on Aging, are an addition to Record Group 182, Tennessee Commission on Aging, 1979-1994. This collection spans the period 1963 to 1994, with the bulk of the material covering the years between 1983 and 1994. The collection consists of approximately four cubic feet of material and is composed primarily of meeting minutes, audit reports, and grant information.

The final disposition of these records was determined by the Records Disposition Authorization (RDA) – RDA S1615 and RDA 823. This RDA permits a sampling of grants; however, since only fifteen fully annotated regional grants were sent with the original collection, all fifteen have been included. In accordance with the RDAs listed above, the material in Record Group 317 has been microfilmed, and the originals were disposed of by the state-approved method.

COMMISSION HISTORY AND INFORMATION

The Tennessee Commission on Aging and Disability (formerly the Commission on Aging) was created by the General Assembly in 1963. As the designated state agency on aging, it must provide leadership on all aging issues concerning older Tennesseans. The Commission provides advocacy, planning, coordination, monitoring, and evaluation to develop or enhance comprehensive and coordinated community-based systems.

State legislation passed in 1998 created a Long-Term Care Planning Council charged with developing a program to guide the future funding, coordination, and delivery of long-term care in the state. Membership includes the Executive Director of the Commission on Aging and Disability; the Commissioners of Health, Finance & Administration, and Human Services; and one member each from the Tennessee House and Senate. New legislation passed by the General Assembly in June 2001 expands the authority of the Commission to include services to disabled persons under age 60.

The Commission also administers state funds providing multipurpose senior center programs, public guardianship, homemaker services, and home-delivered meals. On July 1, 2000, the Commission received \$5 million in state funds to initiate a home- and community-based service program for aging and disabled adults who do not qualify for Medicaid long-term care services.

The Commission is responsible for administering the Older Americans Act, first signed into law by President Lyndon B. Johnson on July 14, 1965. In addition to creating the Administration on Aging, this act authorized grants to States for community planning and services programs, as well as for research, demonstration, and training projects in the field of aging. Later amendments to the Act added grants to Area Agencies on Aging for local needs identification, planning, and funding of services, including but not limited to community nutrition programs for the elderly and/or homebound; programs serving Native American elders and low-income minority elders; health promotion and disease prevention activities; in-home services; and other services, such as the long-term care ombudsman program, which protect the rights of older persons.

The Older Americans Act, Amendments of 2000, was signed into law on November 13, 2000. Public Law 106-501 extends the Act's programs through FY 2005. The reauthorized Act includes the National Family Caregiver Support Program, to help not only family members caring for older loved ones who are ill or disabled, but also those older individuals who are relative caregivers of children eighteen and under. Under grants provided by this program, State and local agencies on aging will work together to provide information and assistance to caregivers, counseling, support groups, respite care, and other home- and community-based services to those families.

The 1981-1982 Tennessee Blue Book was the first edition to list the name of the Executive Director (Emily M. Wiseman, who was named to the position in 1980). In earlier years only Commission members were listed. Previous administrators included Jerry A. McClain, Executive Secretary, 1967-1968; Patti Buchanan, Executive Secretary, 1969-1970; Paul Duncan, Executive Director, 1975-1976; Will D. Drew, Executive Director, 1977; and Tom G. Henry, Executive Director, 1978-1979.

SCOPE AND CONTENT NOTE

The files in Record Group 317 contain organizational data, correspondence, meeting minutes, contracts, and grant data from the Tennessee Commission on Aging (TCA) between the years 1963 and 1994. The bulk of the material in this collection relates to the years 1983-1994, during the period when Emily M. Wiseman was Executive Director. Original order within this collection was fairly casual, so a more consistent order has been imposed in order to facilitate research. After the opening section, which consists of the text of the House Bill creating the TCA and minutes of Commission meetings from 1964-1990, all other files have been placed in alphabetical, then chronological, order. Minutes of meetings have been arranged by fiscal year. Routine office correspondence has been sampled: this material consists largely of memos to area agencies on aging and food distribution, announcing policies, programs, appropriations, and regulatory changes; blank survey forms; copies of agency contracts; and announcements of hearings, workshops, and other calendar items. Audit reports and agency responses have been arranged chronologically. Grant information, since it was not a large body of material, has been maintained in its entirety; it includes applications, quarterly reports, and audit data.

Most of the material in this collection deals with the day-to-day work of the Commission and its regional offices, including nutrition and legal assistance programs. Title III and Title V contracts, including the formulation of an annual State Plan on Aging, are detailed through periodic status and expense reports. Most of the remaining grant money was targeted to fund volunteer programs, from the VISTA project to RSVP (Retired Senior Volunteer Program).
