Scope & Content:

Consists of disbursement forms related to Memphis residents seeking relief and administrative bulletins issued to all Tennessee county emergency relief administrators in 1933-1935.

The forms contain a shopper or county emergency relief official's itemized disbursements of groceries costing up to around five dollars. Articles typically included foodstuffs. On a December 4, 1933, disbursement form Ida Cross (identified as "colored"), ordered flour, meal, lard, sugar, syrup, milk, eggs, butter, peanut butter, fresh vegetables, soap, salt, (baking) soda, cocoa, coffee, and tea at a cost of \$2.25. A retailer then filled the order. In the blank captioned "Beneficiary," Ida signed with her mark of a cross. Citizens also requested standard items like cheese, cereal, potatoes, cooking oil, canned tomatoes, baking powder, beans, rice, spaghetti, and coal oil. All disbursement forms are dated between November and December 1933, with the exception of a few that are undated.

The bulletins, which are numbered 4-348, illuminate the New Deal's attempt to afford work relief rather than dole relief and to "allow opportunities for participants to perform activities related to their ordinary occupations" (H. Bruce Throckmorton, *Tennessee Encyclopedia of History and Culture* website). The

state's chief emergency relief administrator addressed the bulletins to all county administrators.

Administrative/Biographical History

On May 12, 1933, Congress passed the Federal Emergency Relief Act. Less than two weeks later, President Franklin D. Roosevelt appointed Harry Hopkins as director of the Federal Emergency Relief Administration (FERA). The agency distributed grants-in-aid to states whose legislatures met certain conditions and provided matching funds, which Tennessee did. Tennessee Emergency Relief Administration (TERA) projects were spread across the state. In Memphis, it distributed food, clothing, and coal to the needy and hired men to dig ditches and clean streets. According to Throckmorton (previously cited), in Putnam County on the Cumberland Plateau, it built a school at Gentry. Kingsport sought a \$12,500 grant to create relief projects.

The bulletins provide a substantive glimpse into the mechanics of TERA's short life. According to Throckmorton, President Roosevelt and Hopkins realized that "the winter of 1933-1934 would be economically severe if something were not done quickly." By 1935, it became obvious the federal program was not working effectively, so the federal government discontinued it. This development led to the creation of the Works Progress Administration (WPA), which assumed TERA's work relief program.

Lt. Colonel Walter L. Simpson served as TERA's first administrator, and it was he who signed most of the mimeographed bulletins. Early on, Simpson recognized that "inter-relations between the relief work, rehabilitation, and social

service (case work) will necessarily demand that close cooperation be established between the various divisions of the [Civil Works Administration] for the different phases of the relief program" (Bulletin 4). The 300+ bulletins address a wide-ranging variety of matters and offer guidance in dealing with family subsistence and community gardens, women's projects and wages, displaced farm families, urban and rural projects, white collar workers, seed distribution, canning, politics and religion in the workplace, drought relief, food distribution, nursery school lunches, clothing requisition, crop and chattel mortgages, and the chronic poor.
