## **INTRODUCTION**

Record Group 244, Finance, Ways, and Means Committee(Joint), County by County Analysis Summary Sheet Reports is an annual report prepared by the staff of the Joint Finance, Ways, and Means Committee of The Tennessee General Assembly. The reports begin in 1981 and are submitted annually. The current size of the record group before microfilming is five and one half cubic feet. This is an ongoing record group and it will continue to grow.

The reports consist of an eleven page document per county that lists the amount of state taxes that are shared with individual counties. A detailed breakdown of the appropriations for individual entities within the county is included as the basis of the report.

The reports are arranged chronologically and the counties are arranged alphabetically. This is a microfilm only collection; original documents were disposed of according to the Tennessee RDA. There are no restrictions on the use of materials in this record group.

## **SCOPE AND CONTENT**

The Finance, Ways, and Means Committee (Joint) County by County Analysis Summary Sheet Reports is an annual report of the budgetary appropriations by the State legislature. Record Group 244 is an ongoing collection that begins in 1981 and will continue to grow annually. The report consists of a detailed break down of state tax collections and how they are shared with the local governments in an individual county. The report begins with total dollar figures for nine general categories and includes the grand total figures from the previous two reporting years for comparison purposes. The nine general categories are listed as follows: Schedule A-1 & A-2 -- State Tax Collections, Schedule B--Local School Systems, Schedule C--Health and Social Services, Schedule D--Justice and Public Safety, Schedule E--Recreation/Resources Development, Schedule F--Miscellaneous, Schedule G--Separate Facilities, Schedule H-- Capital Outlay Projects, and Schedule I--Transportation Obligations. Each of these general categories contain a detailed summary of taxes shared with the individual counties.

There are two gaps in the annual reports. The reports for 1984-1985 and 1991-1992 are missing. The general information from the missing reports can be obtained from the reports for the following years since each report contains some overlapping information.

These reports were taken over by the Archives and Manuscripts Unit and made into a record group in 1998. Prior to 1998, these reports were catalogued and maintained by the Library Unit. This is a microfilm only collection.
